Clarkson University loves ice hockey. And the North Country loves ice hockey – and some figure skating and curling, too, making ice-plex facilities a common gathering place and rallying point across your entire District #21.

Our alumnus Timothy Rizzo, PE '98, perpetuates our hockey DNA as a past Clarkson student in Potsdam and now a leader in Johnstown in Fulton County. He is spearheading a sentimental project inspired by Mrs. Cleland, his kindergarten arts teachers, to complete a recreational facility for community winter sports.

We know that Clarkson's Cheel Arena in Potsdam, built in 1990 and named in honor of the legendary Helen Snell Cheel -- the daughter of North Country Congressman, House Minority Leader and Clarkson Board Chair Bertrand H.
